### **SECTION 1**

### 1.1 INTRODUCTION

The CRL/SOMMER & MACA Glass Cutting Table is made to perform well over a long period of time. Follow all safety rules as specified in this manual. Treat the table top with respect by keeping clear of it when it is in motion, as it can be quite heavy, especially when holding large pieces of glass. Pay attention to the counter-weights when they are placed. The proper counter-weight will make the table top easier to handle.

#### 1.2 UNCRATING

Before the table was crated/skided for shipment, it was inspected for proper working condition. Therefore, proper uncrating and inspection upon receiving is of the utmost importance to assure that the table was received in exactly the same condition as it was when shipped from the factory. The table and all ancillary components are shipped in one large crate.



The skid with the table is heavy. Use adequate lifting devices to move the skid and avoid damage to the table.

#### **INSPECTING THE SKID**

- 1) Skid damage could indicate mishandling during shipment and the table could possibly be damaged. Inspecting the crate for exterior damage is an important part of the uncrating procedure.
- Check all surfaces of the table and skid for gouges, tears or holes that could have been caused by the tines of a fork-lift or other lifting device.

#### **IMPORTANT SAFETY INFORMATION** 1.3

















- Always operate and maintain the Cutting Table in accordance 1) with the instructions and procedures in this manual.
- Do not exceed the capacity of the table. 2)
- 3) **Do not** open electrical panels while unit is in operation except in special circumstances which are addressed later in this manual.
- 4) Never work on the table and related components unless electrical power and motor drive have been locked out and tagged.
- 5) **Do not** use table for any purpose for which it was not designed. It is to be used solely to cut glass within the specification limits listed in this manual.
- 6) Always have a clear view of the loading and unloading points and all safety devices of the table.
- Always keep area around cutting table free of debris and 7) obstacles.
- 8) Never operate cutting table without guards and all safety devices in position and functioning.
- 9) Always allow Tabletop to stop naturally. Do not attempt to force the table top up or down. Check for obstructions if resistance is encountered.
- 10) Always wear safety glasses, proper gloves, and other necessary safety equipment while operating and maintaining the table. When in doubt, consult with shop safety representative.
- 11) Never work on the underside of the table (with the tabletop in the upright position) unless there are proper supports holding the tabletop up. 2 wooden supports from the floor, inside the table frame, to the top of the tabletop would be sufficient. An additional support from above such as a rope or sling attached to the latch would provide further safety for any work being done on the underside of the tabletop.

### **SECTION 2**

#### 2.1 ASSEMBLY

- 1.) After uncrating the frame and decking, orient the table frame as shown in the diagram below. **Important Note:** Make sure the pre-drilled holes for the decking are on top.
- 2.) Mate the tubes together and insert the bolts through the holes provided.
- 3.) Tighten the bolts, alternating from one side to the other to ensure an even draw.
- 4.) Inspect the joint when both bolts are torqued to 40 ft/lb. There should be an even butt at both joints.
- 5.) Extension arms are located on each corner of the lower frame. They should be rotated for all 12' (3.6 m) long table frames as to support the table top.
- 6.) Remove the shipping lumber. Lay the tabletop in horizontal position, insert the 2 pivot pins and lock it in place with the "Locking Latch". Check the latch for proper operation. See below for latch identification.
- 7.) Mount the casters and floor locks to the base with the hardware supplied. Refer to figure 2 on page 11.

ASSEMBLY PROCEDURE FOR SPLIT CUTTING TABLE FRAME



#### 2.1 ASSEMBLY - continued

- 8.) Layout the table top decking on the table frame. The decking is match numbered with the frame of the table top. Place the corresponding decking over each section (see figure 1, p.11). The frame and decking has been pre-drilled. Note: There should be a 5/16 3/8" gap between the center decks. This is to allow for a breaker bar in the future. Place a continuous bead of silicone or construction grade adhesive between the decking and the frame. Use care to insure that the decking is lying smoothly together and that the mounting holes are positioned over the corresponding holes on the frame structure. Do not fasten the last two decking pieces yet. Place the recommended counterweight (see figure 1) in the table top pans equal to 230 lbs.(104 kg.) for the 8x10, 230 lbs.(104 kg.) for the 8x12, and 300 lbs.(136 kg.) for the 9x12. Fasten down the decking (see step 9) with two screws each on panels "1" & "4" on a 4 panel table and "1" & "6" on larger tables after the counterweights have been added. Place 270 lbs.(122 kg.) for the 8x10, 270 lbs.(122 kg.) for the 8x12, and 300 lb.(136 kg) for the 9x12 in the base pan (see figure 2). As a general rule, fill the base counterweight pan about 3/4 full with heavy material.
- 9.) After the preliminary installation of these last two (2) pieces of decking, mount the Toe Assemblies to the frame. Place a test piece of glass on the table and release the table latch. If the counterweight is sufficient, install permanent weights and the rest of the decking fasteners. If not, alter the weight in the pans to achieve balance.
- 10.) Vacuum or wipe off the decking before proceeding. Install the carpet. The carpet is cut oversized, 144" (3.6 m) wide x 152" (3.8 m) long. Roll out the carpet and center it over the table top. Smooth out any wrinkles that may have been caused during shipping. Position the carpet for the desired overhang. Center the carpet over the top. Roll the back section of the carpet toward one edge of the table. Apply a light even coating of low adhesive carpet glue (provided) to the decking surface. Roll the carpet back, smoothing out the wrinkles as you go (Tip: use sheets of glass to assist in smoothing out the carpet). Cut off the excess carpeting leaving enough to staple to the underside of the table decking. Allow sufficient time for the adhesive to dry. Follow adhesive instructions.
- 11.) When Air Flotation is furnished, cut the carpet flush to the sides of the holes by using a sharp knife. Mount the ball check assemblies from the opposite (bottom) side with the hardware supplied. Attach each hose to the ball check assemblies and to the respective port on the blower unit.

Note: Only single phase, 110 volt (1/60/110v) blowers are supplied with power receptacles. Other voltages will require wiring the motor to your power source. If you are not comfortable doing this wiring, <u>Hire a Professional Electrician</u> to hook up the table top blower.

12.) When a Breaker Bar is furnished, cover the breaker bar cavity with tape, prior to gluing down the carpet. Follow sequence #5. After the glue has dried, use a sharp knife to remove the narrow strip of carpet above the breaker bar.

### **INSTALLING TILT STOPS (BUMPERS)**

Rubber bumpers need to be affixed to the lower portion of the front (hinge end) of table base. There are two (2) segments of 1" (25 mm) square tubing 36" (914 mm) long that straddle the lower front of the base.

Remove the protective backing from the four (4) rubber bumpers 3/4" x 1" x 3" (19 x 25 x 76 mm) long and press bumpers approximately 6" (152 mm) in from each end. Bumper material may be supplied in one 12" piece. Cut into 4-3" pieces. A set of bumpers should make contact with the underside of the counterweight pans. This also acts as a stop, for the table top.

### **SECTION 3**

#### 3.1 INSTALLATION

# INSTALLATION, SET-UP AND OPERATING INSTRUCTIONS FOR TILT-TOP CUTTING TABLES

The CRL/SOMACA Tilt-Top Cutting Tables are well-made and designed to be safe for the operator and any employees in the immediate work area. It is very important to assemble and set up the table as described in this manual. Annex B, C and D will show how the table should be installed in your shop. Observe and clearly mark off **Safety Zones** and **Contact Areas** See Pages 18-22. (Danger Zones where operators may come into contact with the moving table top).

Maintain minimum spacing between the table and structures in the shop. This will prevent employees from being trapped behind or around the table top while in operation. You may have to construct walls, guards or other structures to prevent intrusion into **Danger Zones** (see Annex B.2, page 19)

The table top itself is <u>at least 500mm (approx. 20 inches) larger</u> on each side than the table base and therefor an operator or employee standing too close to the table base may be in danger of contact with the table top as it is lowered. Clearly marking **Danger Zones** on the floor around the table, or installing opti-electric barriers (in the case of hydraulic tables) may prevent this type of dangerous situation.

Make sure the Glass Strap is in place and holding any large sheets of glass when the table is tilted up. This strap will keep glass sheets on the table and not allow them to be catapulted off into the shop area.

When the table is positioned safely in the workspace, be sure to lock the table into place with BOTH floor locks. If the table is moved from one place to another in the shop, be sure that all workspaces where it is used are safe by following the guidelines in this manual.

#### 3.2 OPERATING INSTRUCTIONS



# • IMPORTANT! Follow all safety instructions when operating the Tilt Top Cutting Table

- 1. Extend the wooden toes before tilting the table up.
- 2. Release the locking latch and remain on the Latch Side and assist the tabletop to it's upright position being careful not to let go. DO NOT stand in front of the table or allow anyone to do so during the loading or unloading process.
- 3. Load the glass onto the wooden toes making sure that the glass is resting fully on the table.
- 4. Attach the retaining strap across the glass to hold it firmly to the carpet surface.
- 5. Assist the tabletop down to the horizontal position making sure the locking latch is fully engaged into the frame.
- 6. Retract the toes and position the glass on the cutting surface using the air float (if equipped).
- 7. Score glass and run it by extending breaker bar vertically (if equipped).
- 8. If removing a large section of glass, extend the toes, position the glass to be removed against the toes and attach the retaining strap across the glass to prevent possible "catapulting". Now raise the table as instructed in step 2 above.

### **SECTION 4**

#### 4.1 BREAKER BAR ASSEMBLY - FIELD INSTALLATION

NOTE: The breaker bar and frame are pre-drilled at the factory when ordered with the table.

- Orient the Breaker Bar assembly to the position where the operating handle is desired. Clamp the back of the Breaker Bar assembly 1/8" (3.2 mm) from the inside of the frame tube (see diagram).
- 2.) Locate the mounting holes in the angle bracket of the Breaker Bar assembly. Mark the hole positions on the tube that the breaker bar is being mounted to. **NOTE:** Accuracy is important in this step.
- 3.) Remove the Breaker Bar assembly from the frame. Find the exact center of each hole and using a transfer or center punch, mark each hole with a hammer blow to the punch.
- 4.) Using a 1/8" drill bit, drill the holes ONLY through the bottom of the tube. When completed, re-drill the holes with a #3 drill (.203"), again only through the bottom of the tube.
- 5.) Tap each hole with a 1/4-28NF Tap. The fine thread is recommended for this application.
- 6.) Re-install the Breaker Bar assembly and tighten each bolt to 10 ft/lbs. Loctite 242 (blue) retaining compound may also be used on the fastener's threads during assembly.

Use of opto-electronic barriers (single light beam)

- 1) Opto-electronic barriers have to be used preferably if the area has to be entered frequently
- Distance between opto-electronic barrier and rear edge of tilting table ≥ 600 mm; at the side 400 mm to prevent crushing and impact of the body, ≥ 800 mm where there is a risk of crushing of the hands
- 3) Height of the opto-electronic barrier above floor 0.75 m (29.5") (beam path)
- 4) Positioning on 3 sides around the tilting table, e.g. by use of mirrors
- 5) Dopto-electronic barrier (CLC/TS 61496-2:2006, category 4) (
  - 6) Reset (additional) if there is no good view of the danger zone at the control desk
  - 7) The use of the reset or of the start actuator respectively from inside the danger zone shall be excluded.

#### LIMITATION OF LIABILITY

SELLER'S SOLE REMEDY SHALL BE REPAIR OR REPLACEMENT OF DEFECTIVE PRODUCT.
